Subject : Minutes of the Meeting on Real Time Market Regulations and 5th amendment of DSM.

The meeting was held on 20.03.2020 through Video conference . The representative of BRPL BYPL TPDDL PPCL/IPGCL attended meeting Video conference .NDMC representative attended along with SLDC at Conference Hall , Delhi SLDC Minto Road.

The following was the gist of the discussion and decisions:

It was intimated that CERC has decided to implement Clause 18 of Regulation 6.5 of part 6 of IEGC 6th Amendment i.e. Real Time Marketing(RTM) and Clause 10(b) of Regulation 7 of DSM 5th Amendment w e f 01.04.2020 (Subsequently differ to 01.06.2020)

1. Silent feature of the mechanism of RTM are as under.

“Any revision in schedule made in odd time blocks shall become effective from 7th time block and any revision in schedule made in even time blocks shall become effective from 8th time block, counting the time block in which the request for revision has been received by the RLDCs to be the first one. “

- a) Above clause is applicable for all ISGS including BAWANA CCGT. In this regard, Delhi SLDC informed that 1 block for ISGS further required by SLDC in addition to 7 and 8 time blocks to process the revision. However Discoms requested to reduce that time ,so it was decided that if all the Discoms would provide their requisition within first 5 minutes of a block, then SLDC would process the revision as per the above clause, otherwise 1 extra block would be needed.
- b) However in case of Bawana CCGT, 2 extra blocks would be required by SLDC because of Punjab and Haryana. Share in the station
- c) Further in case of Delhi Gencos i.e. Pragati, GT, revision of declared capacity and schedule would take place as per earlier IEGC, i.e. 4 time blocks.
- d) Further, a concern was raised by SLDC that sometimes Delhi Gencos send the notification in Message portal regarding revision of DC and SG instead of punching in Web portal. It was clarified that the DC and SG values punched in Web portal would only be considered for the finalization of accounts. Notifications in Message portal without punching in web portal would not be entertained.
- e) Delhi Gencos raised their concerns regarding Ramp up and Ramp down during tripping.
It was suggested that Gencos and SLDC software team would sit together to find the appropriate provisions in Software.
- f) It was emphasized that it is the responsibility of all stake holders to cooperate for smooth implementation of the System for overall efficiency of the Power System operation

A meeting is scheduled to be held on 20.03.2020(Friday) at 11 AM at conference hall of Delhi SLDC, on the above cited subject.


The following points would be discussed in the meeting:
